

MINUTES – NOVEMBER 1, 2021

Minutes of Regular Meeting of the Board of Trustees of the Village of Glen Park held on November 1, 2021 at the Municipal Complex, 642 Main Street, Glen Park. Mayor Stephen Macaulay called the meeting to order at 6 p.m.

Upon motion made by Joan Postorino, seconded by Larry J. Brown, the reading of the minutes was dispensed with and the minutes of the regular meeting of October 4, 2021 were accepted as presented by Village Clerk Constance G. Hoard. CARRIED.
