#### **Board of Trustees**

- We wish everyone a happy, healthy and safe holiday season!
- When the City of Watertown had its water emergency in October some Village residents were concerned if that emergency effected the Village. You may have received text alerts about the emergency. We believe that was because of the reverse 911 was put out to the zip code area 13601. Our source of water is purchased from the Village of Brownville, which have their own wells. When Brownville's wells run low, they are able to purchase water from the Development Authority of the North Country (DANC). DANC's water line is supplied from the St. Lawrence River in Cape Vincent and follows State Route 12E servicing the communities from Cape Vincent to the Village of Brownville.

### Department of Public Works 315-782-8081

- Reminder no overnight street parking from November 1 to April 1 from 2:00 AM to 6:00 AM.
- Do not put garbage/recyclables on the sidewalk during winter months. This hinders snow removal on the sidewalks.

## <u>Treasurer/Deputy Clerk</u> 315-782-2143

- Reminder the Treasurer does not collect Town/County or school taxes; Village taxes only due in June.
- Remember you have the option to pay water/sewer invoices online at <a href="https://www.glenparkny.com">https://www.glenparkny.com</a> for an additional fee; 3% for credit cards and \$1.50 for echecks. You will receive an email confirmation receipt.

#### <u>Clerk</u> 315-782-4508

- Village election is Tuesday, March 19, 2024 at the fire station from noon to 9:00 PM. The positions of Mayor and two trustee are up for election for a term of two years.
- For a name to appear on the ballot, an independent nominating petition can be filed between February 6 and February 13 with Clerk Hoard, 116 East Main St., Brownville, NY. Petitions can be picked up at the Village office or Clerk Hoard's home between January 2 and February 6, 2024.
- Absentee ballots the last day for the Village Clerk to mail absentee ballots to qualified voters is March 13, 2024. To receive your absentee ballot in a timely matter, please notify the Clerk or Village office the mailing address for the absentee ballots even if you have registered the absentee ballot request with the Jefferson County Board of Elections. The absentee ballot would be returned to the Clerk's residence at 116 East Main St, PO Box 518, Brownville, NY 13615. The absentee ballot must be received no later than the close of the polls on election day, Tuesday, March 19<sup>th</sup>.

Phone, text and email scams are on the rise and scammers are becoming more and more sophisticated in their tactics. They may call you claiming to be a family member in legal trouble needing bail money. They might claim your accounts are in danger of being closed, utilities will be shut off or threaten you or your family with legal action. Scammers rely on creating a sense of urgency to get you to act without thinking. These high-pressure tactics are red flags of a scam.

- Don't rely on caller ID-scammers can make it seem that they are calling from a legitimate business
- If you are suspicious of a call, text or email, contact the business through their published phone number
- Never give sensitive information- PINs, account numbers, social security number, etc.
- Never click on an unsolicited link sent via text message- especially if it asks you to sign in to your bank account
- Be skeptical of every email-often, the scammer will disguise the email to look and sound like it's from your bank or other legitimate business.
- If they tell you that you have to pay a bill using gift cards-IT IS A SCAM!

#### What to do if you fall for a scam

- If you gave a scammer personal information like your SSN or bank account number, go to IdentityTheft.gov or call (877) 438-4338 to see what steps to take, including how to monitor your credit.
- 2. Change your password if you shared any sort of username or password.
- 3. Contact your bank and/or credit card company.
- 4. If you lost money, file a police report by calling 315-786-2601.
- Report the scam to the Federal Trade Commission or call 1-877-FTC-HELP (382-4357).
